## Activities Report for the year 2022-2023

(Action taken on Annual Action Plan 2022-2023 approved by the 23rd General Body Meeting etc.)

## A. Projects under National Bamboo Mission.

- Incense stick processing unit: Out of 9(nine) applicants received, 3 applicants were shortlisted on submission of further required information by BDA and spot verification was carried out and recommends S.K Bamboo Industry Chhingchhip and Charcoal making cooperative society, Chhuanthar, Baktawng based on land, raw material, power, labour availability and experience. Advertisement for inviting EOI in local newspaper maybe floated for the remaining 6(six) units.
- ii) Management of Bamboo Waste in primary processing units: Out of the 5 (five) applicants received, 4 applicants were shortlisted on submission of further required information by BDA and spot verification was carried out and recommends S.K Bamboo Industry Chhingchhip based on land, raw material, power, labour availability and experience. The remaining unit is proposed to be taken up by BDA to produce raw bamboo charcoal by drum method by engaging different village community for supply to existing Bamboo charcoal briquetting unit at Bamboo Technology Park, Sairang.
- Handicraft/ Cottage Unit (Private): One application was received from ZX Bamboo & Wood works, presently shifted to Industrial estate, Zuangtui and site verification was carried out. The unit is recommended based on land, raw material, power, labour availability and experience.
- iv) Establishment of Processing unit for value addition of bamboo: This unit is located at Industrial estate, Zuangtui on the ground floor of Export Import Business Training Centre and is taken up by BDA for production of Round Agarbatti stick wherein 5070 kgs has been produced so far. In order the unit be managed more efficiently, it is proposed to outsource the same to private players through proper channel and agreement.
- B. Project under promotion of MSME in North East Region & Sikkim. BDA has prepared project proposal "Development of Existing Industrial Estate at BTP Sairang" amounting to Rs. 7,25,00,000/- for which an SMS of Rs. 72 lakhs has been requested to the State Government.
- C. Export Import Business Training Centre (EIBTC): For completing construction of EIBTC at Zuangtui Industrial Estate, Project amounting to Rs.3,11,00,000/- has been

prepared by BDA and request has been made to Planning & Programme Implementation Department, GOM for inclusion as state priority list to be taken up under NEC.
