## TERMS AND CONDITIONS FOR LEASE OF AGARBATTI STICK MAKING UNIT AT EIBTC, ZUANGTUI.

The following Terms and Conditions are laid down for lease of Agarbatti Stick Making Unit at EIBTC, Zuangtui. The bidding Firms are expected to go through the Terms and Conditions and to submit their bids only after careful consideration the following points -

- 1. The applicant should submit application duly filled in by envelope mentioning Name, Address. Envelope should be superscripted 'Application for lease of EIBTC, Zuangtui'.
- 2. The envelope should be addressed to:

- 3. The applicant should have GST reg. no. which must be supported by document(s)
- 4. The period of lease will initially be for a period of one year (twelve months) starting from the date of signing Memorandum of Understanding (MoU) and will be subject to revision after every six months.
- 5. The applicant must have a minimum of three years experience of running any other kind of Industries and must have qualified and experienced technical personnel to maintain the machines.
- 6. Any official from BDA may inspect the site on any working day with prior information to the applicant.
- 7. Minimum Reserved rent is Rs. 8,600/- (Rupees Eight Thousand Six Hundred) only per month.
- 8. Revision of rent shall be made as deemed necessary.
- 9. Renewal of Agreement shall be subject to fulfillment of all the conditions.
